General Terms & Conditions of Sale

These **General Terms and Conditions of Sale** govern the sale to buyer of goods covered by this quote. A signed copy of these Terms and Conditions must be either returned to Tubular Structures via **text message:** to 601-947-5642, **email:** tubularstructure@bellsouth.net or by **USPS** with your down payment.

Please initial by each term & condition after reading:

1) KIT ONLY Setup:

Included in your KIT ONLY setup Tubular Structures will:

- Setting and squaring the 4 corner posts
- Setting and squaring the 2 end hoops
- Build ONE (1) endwall

2) Payment

We will call **(2) weeks** prior to your tentative delivery/setup day and request that you send your down payment check for \$2900.00. Once we receive your down payment we will schedule a definite date for delivery/setup. If you are not ready your name will be moved to the bottom of the list. Your delivery/setup will be scheduled according to the date we receive your contract and down payment. During Hurricane Season this can be longer due to the inclement weather. Final payment is due the day of kit delivery. We DO NOT price match. Our prices are FIRM.

3) Ground Preparation:

Upon receipt of your contract a courtesy copy of Ground Preparation Guidelines will be emailed to the email address on file. These guidelines are provided so that when our delivery crew arrives they can begin without delay to setup your KIT ONLY basic framework. If Tubular Structures delivery crew arrives onsite with a kit and the ground is not prepared according to ground preparation guidelines we will drop off your kit without squaring up the ground or assisting in standing end bows. Full payment of invoice will be due before our crew departs. If customer desires Tubular Structures to return and set up the start of their KIT ONLY then a fee of \$750.00 is required before our crew will be sent back to set up the customers KIT ONLY. **We DO NOT ASSIST in ground preparation due to time restraints and strict delivery schedules. If the customer does not want delivery without our assistance then the kit will be delivered to the next customer on the list and the customer has the option of contacting us when ground is ready.**

4) Restocking Fee:

If this contract is terminated prior to installation but after down payment is received a restocking fee of 50% will be charged. The only reason for not charging a restocking fee is if a Medical Condition prevents client from accepting the High Tunnel or if the NRCS contract is void. Once your contract is signed, payment is received and your structure is delivered there are NO REFUNDS.
